

FREQUENTLY ASKED QUESTIONS

How do I know if my student is right for the CTRL program?

Below are admission factors we consider when consulting with counselors and/or parents.

(Q) Is the applicant seeking coursework for first time credit?

(A) CTRL only offers classes for first time credit so if the student needs a credit recovery option then our Success Center (which offers both Credit Recovery (CR) and First Time Credit (FTC)) might be a viable option.

(Q) Is the applicant seeking to maintain their NCAA athletics eligibility?

(A) CTRL has and will strive to continue serving student athletes who experience scheduling challenges and conflicts because of issues like their Tulsa Tech program, AP coursework, Sports, etc.

(Q) Does the applicant have a transportation hardship or burden that prevents them from attending Success Center?

(A) On an individualized basis, we will consider transportation hardships alongside other factors when considering admission.

(Q) Does the applicant have a history of success in other online classes?

(A) Because CTRL utilizes similar coursework to other Edgenuity classes, previous successes or failures in that realm can provide useful information for considering admission.

(Q) How does Edgenuity address academic integrity issues?

(A) Edgenuity has several mechanisms for detecting cheating and plagiarism. Therefore, CTRL values students with the highest standard of academic integrity. Issues found with a student's academic integrity can and likely will result in dismissal from the course and they will not be eligible to reapply to the program.

(Q) Is the applicant seeking a course not available at their home high school or not available because of a conflict with **Tulsa Tech program scheduling?**

(A) CTRL has and will strive to provide flexibility and schedule relief for students who find themselves in these rare conflicts. Individualized circumstances will be considered.

(Q) Does the applicant have a history of excellent work ethic and study habits?

(A) CTRL is largely done independently with weekly teacher check-ins and scheduled appointments (as needed) between instructor and student. Because of this structure, it is imperative that the student have a high degree of self-motivation and strong study habits.

(Q) Does the applicant have internet access at home?

(A) Because these courses are one-hundred percent online we do require the student have internet access from home in order to keep up with the work.

(Q) How much does it cost to take a CTRL course?

(A) Each semester course costs \$45. Once tuition is paid no refunds will be possible.

(Q) Can students enroll in more than one course at a time?

(A) No. Students can only enroll in one semester course at a time regardless of the number of course requests on their application.

(Q) What is the time limit to complete a course?


(A) 14 weeks. However, adjustments to the length can be made situationally (i.e. NCAA, Early Graduation, Summer School) and should be discussed and agreed to during the enrollment process.

(Q) If I want my student to be considered for the CTRL program what should I do?

(A) Consult your student's home school counselor to make sure they agree with, and will endorse, the application and then fill out the application to completion.
