

Credit for Prior Learning Application Guidelines

Definition

Prior Credit Evaluation is the process by which a student requests to receive credit for previously completed coursework or industry certification (Industry Certification is Allowable for Aviation Programs Only).

Eligibility

Applicants must be admitted to a Tulsa Tech program and be able to demonstrate that they have previously completed coursework that may be eligible for prior credit by providing a transcript from previous institution(s) as well as a course syllabus for each course being evaluated. For Aviation programs, a student must submit a copy of their FAA Mechanics Certificate. Process

- » Students will receive information about Prior Credit Evaluation from Admissions once they have completed the application process.
- » Students must be admitted to a Tulsa Tech program.
- » Students must complete the Prior Credit Evaluation Application and submit supporting documentation to Student Services two weeks prior to the beginning of class.
- » Qualified veterans may be required to provide transcripts of credit recorded at other educational institutions or military training facilities.
- » Students will be notified of either denial of hours or hours awarded and first day of class by Student Services.

Considerations

- » Students will not be awarded financial aid including scholarships if eligible until Prior Credit Evaluation is complete.
- » No course partial prior credit will be awarded, and no more than a possible 50% of program total hours will be awarded.
- » Credit awarded from other institutions will be indicated on the student's transcript with a grade of "T". Tulsa Tech coursework accepted for PC in the same or a different program will not appear on a transcript with a grade of "T".
- » Prior Credit will not affect a student's GPA.
- » Course work must have been completed within the previous 5 years and meet grade and hour crosswalk requirements.
